

Instructions and procedure for filing online ITEP application

The applicant institutions are requested to read the following instructions/documents carefully, before filling online application: -

- NCTE Act 1993.
 - NCTE Regulations, 2014 (Recognition Norms and Procedures), as amended from time to time.
 - The National Council for Teacher Education (Recognition Norms and Procedures) Amendment Regulations, 2021 published in the Gazette of India, Extraordinary, Part III, Section 4, *vide* Notification No. **NCTE-Regl011/80/2018-MS(Regulation)-HQ**, dated the 26th October, 2021 and **F.No. NCTE-Regl.022/05/2021-O/o DS(Regulation)-HQ**, dated the 19th October 2022 and **F.No. NCTE-Regl.022/16/2023-Reg.Sec.-HQ**, dated the 30th January 2024
 - Public Notice dated 15.03.2024.
 - Public Notice dated 22.04.2024 inviting ITEP application.
 - Shortlisting Criteria for Processing of Applications.
 - Guidelines to fill GIS details.
- Before filling up the online Form, applicants are requested to read carefully the related Notification/ Advertisement available at the Website and also ensure that the Institution is eligible in terms of the conditions/provisions mentioned in the Shortlisting Criteria.
 - The web link to fill up online application will remain active from 22.04.2024 to 21.05.2024 (till 11.59 p.m.). Institutions are requested to fill the online application well in time/advance, without waiting for the last date of applying to avoid any network congestion/hassle. NCTE will not be responsible for any inconvenience caused due to network error.
 - **Those institutions which have already registered for ITEP 2023-24 and 2024-25 need not register afresh. They may directly login with the provided credentials.**
 - Applicant Institutions are requested to fill the correct and complete details, as this information shall be recorded and used for further evaluation, communication, and references.
 - Applicant Institutions are requested to keep all relevant documents (including Society/Trust/Company Registration Certificate (If applicable), copy/copies of NOC of affiliating body (If applicable), Land Details Certificate and Building Completion Certificate etc., ready before starting the form filling process.
